Benefits of admitting a patient from an intervention

- The patient/client has had a say in going to treatment.
- The patient/client has been treated with respect.
- The family has shown their love and tolerance for the first time in a long time.
- The patient/client has a clear understanding of the length of stay.
- The patient/client knows this is his/her last chance to save the relationship(s), job and sometimes freedom.
- ► The interventionist has worked with the family for many hours and each of the roles in the family system.
- The interventionist has a consequences letter from each family member, and they will follow through if they do not complete treatment in its entirety.
- The interventionist is available to intervene if the client is acting out or potential ACA.

What to expect during the initial call to your facility, from the interventionist



- You will be given front and back of insurance card and DOB for a VOB
- You will be given contact person's (not the PT) contact information to collect any monies owed. OOP, deductibles or private pay
- Date of Intervention and admission (Secure Bed)
- ► The minute PT is in the car, interventionist will call for a phone intake and approximate ETA will be given
- If flying, staff will be given a photo of PT, to assist in finding him/her at the airport


What is the process for an intervention?

- Initial phone call from loved one
- Contractual AgreementSigned and datesdetermined
- Pre-intervention
- Intervention
- Admission into facility
- Family treatment/workshops

INITIAL CALL INFORMATION GATHERED DURING THIS CALL



- Who they are to the patient
- Patients DOC
- How long they have been using
- ► Why now?
- Have they spoken to them about treatment and what was their response?
- Any physical restrictions?
- Insurance
- DOB
- Legal issues
- Prior TX and did they complete/ACA



CONTRACTUAL AGREEMENT SIGNED

Pre-intervention

- -Identify family roles
- -Letters from the heart
- -Consequences/bottom lines
- -Strategic planning
- -Identify reasons why they "can't go", and have a solution for every one of them
- -Build an alliance
- -Answer all questions until family is comfortable and confident



INTERVENTION DAY



WHAT OCCURES AT THE INTERVENTION?

- Everyone walks in together, takes a seat
- Interventionist introduces themselves
- Patient is asked to take a seat and just hear the family out. Explain they all worked hard on their letters, and we would love for you to just listen to what they have to say
- Each participant will read the letter to the heart, filling the room with love and reminding the patient what life was like before they started using
- Patient is asked periodically during the intervention if they would agree to go into treatment today
- As soon as patient agrees to go, the family gives hugs, and the patient is escorted to the car and safely transported to the treatment center
